#### **FEMA Accreditation Submittal**

James Heyen of WEST Consultants is working on the MT-2 submittal. The City has not yet gotten back to SDIC regarding its desire to get updated LiDAR to include in the flood mapping analysis. It was the consensus of the board to ask attorney Jeff Condit to look into the notice-to-landowners process and who is responsible for it.

### **House & Office Renovation**

The SDIC received four bids for roofing the district house/office building. Gary Wheeler made a motion to accept the bid from Comfort Construction for \$11,640 for barge rafter repairs and a new roof. Jeff Mapes seconded the motion, and all voted in favor of it. President Wenker will sign the acceptance of the bid.
